- 8) Neighbourhood Plan update CS reported Since my last report we have prepared and issued a Call for Sites. The purpose of this was to encourage householders and land owners to put forward sites that they thought could be used for housing, employment or amenity.

A 'Call for Sites' poster was put on various notice-boards around the village and a flyer was delivered to every dwelling in the parish. The deadline for responses was 31st October 2019 giving people six weeks to respond.

The Call for Sites notice pointed people to the Earl Soham website where they could download the applications form. Alternatively they could contact the parish Clerk and a form would be delivered and some people did do this.

I am pleased to say we have received eleven responses.

These will be forwarded to AECOM who will do an analysis of the sustainability of the submitted sites. I would like to stress that just because we have received an application it does not mean that site will be included in the neighbourhood Plan. Also the sustainability assessment is being done by AECOM who are a professional third party company nominated by Locality on behalf of Department of Communities and Local Government.

I am currently in dialogue with AECOM to start the site assessment process.

In the meantime the team is looking at other aspects of the Neighbourhood Plan such as footpaths and views.
